Section 8 Conclave 2009

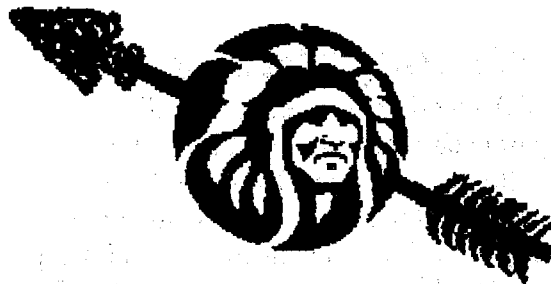
